- Dutch Copyright Act: copyright duration 70 yeas after death of director, screenwriter, dialogue writer and music composer
 - Director, screenwriter, dialogue writer and music composer died before 1941: public domain

 - No information on director, screenwriter, dialogue writer and music composer
 MAY BE PROTECTED = ORPHAN
